Over the years since then improvements were made and in 2002 a new building was constructed at a cost of £750,000 and this was used until 2017 when it closed, not as a result of lack of use, but due to management issues. At that point it was being used for bingo, drama, choir, playgroups, parties, sports, exercise classes, snooker, church groups.  In the next 5 years it is expected to host a café and small shop whilst offering pre-school, softplay, workhub, exercise classes, clubs, youth services including guides, church groups, bingo, knit and natter for the elderly, outreach space for welfare services, police, childrens services etc.  The Centre offers an opportunity for a local hub to the numerous new estates in the area like Park Place, Dicken's Gate, Stone Close etc. More new housing is anticipated and a large, local Community Centre would help deliver a reduction in car journeys and hence carbon emissions.  We have over 300 signatures on a petition objecting to the development. See attachments.  Over 70 people made objections to the Community Consultation which according to Council Officers was quite exceptional.

It is particularly popular because it is observable from the housing around and therefore perceived as safe.
