## Wiltshire Council Proposal for No Waiting at any time on the Bradford Road

Wiltshire Council has informed us of a proposal to install double yellow lines along Bradford Road from the junction into the Rudloe Estate, past the school entrance to beyond the bend (see below plan). If this is approved, those of you who park on the Bradford Road and use that school gate and will no longer be able to do so.

As a school we are against this proposal as we recognise using the gate relieves a lot of pressure on the Broadwood Avenue access road which has restricted access, especially for coaches. It would also result in increased traffic on to the Rudloe estate and adversely affect local residents which is a serious concern to the school.

We have also found that cars parking along the Bradford Road has the effect of reducing the speed traffic travels along the road, making it safer for many of you to cross.

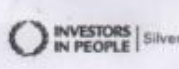
One of the reasons this change has been proposed is because there have been occasions when parents have parked inappropriately which have been observed. 
